Original degree(s) and mark sheet(s) of 10th, 12th, qualifying examination (i.e Graduation final semester/year DMC alongwith downloaded CET PG 2024 result card) and Gap Year Affidavit as the case may be should be produced at the time of Counselling. A Character Certificate from the last institution attended by the candidate MUST be produced **on the date of Counselling.** In the absence of proof of having qualified with requisite percentage of marks, the admission granted shall automatically stand cancelled.
- 3. Original and appropriate certificate (as per format given in the Handbook of Information) for claiming reservation under a category must be produced by the concerned candidate. Affidavit in the prescribed format must also be produced where required.

The eligibility of candidates shall be provisional at every successive stage of admission process. It will be the responsibility of the candidate to make sure about his/her eligibility and fulfillment of various conditions for admission as prescribed in the University Handbook of Information 2025 and as per other Rules & Regulations of the University. Admission can be cancelled at any stage in case the candidate is found to be ineligible.

After admission, a Migration Certificate would be required from the University/Institution last attended by the candidate in case the admitted candidate belongs to an institution other than Panjab University, Chandigarh.
