- In the month of November odd semester examinations (regular and reappear) i.e. 9. 1st, 3rd and 5th semesters shall be held and in the month of May even semester examinations (regular and reappear) i.e. 2nd 4th and 6th semesters shall be held. Provision: However, students having reappear in5th semester shall be allowed to take up the reappear examination in the month of May along with 6th Semester.
- 10. That I understand that any optional subject in any semester shall not be offered if less than 25 students opt for it. I undertake not to make a claim for such optional subject.
- That I understand that in case of any illness, medical certificate has to be submitted within a week from the date of joining the department in order to claim the benefit of condonation of lectures.
