INFORMATION 2026 AFFIDAVIT/UNDERTAKING (on stamp paper worth Rs. 5/- duly attested by Oath Commissioner/Notary)

I _____ Son of/Daughter of _____ Age _____ years (having Aadhaar No. _____ Mobile No. _____ and email _____) am resident of _____ seeking admission in Class/ Course / Department _____ of Panjab University, do hereby solemnly affirm and declare as under:

1. That I would seek prior permission from the concerned authority of the University for organizing any protest, dharna or rally etc at the designated area for settlement of my genuine and justifiable grievances from the competent authority.
2. That I would organize the protest, dharna or rally etc for settlement of my genuine and justifiable grievances within the designated area i.e. Ground by the side of Police Chowki/Health Centre/Dispensary near market in the University Campus as notified by the Registrar vide notice bearing No. 122/R/DS dated 29.04.2022.
3. That I would not organize/participate any protest, dharna or rally etc in the residential areas on both the campuses i.e. Sector-14 and 25 of the Panjab University, Chandigarh or any of the campuses of Institution/Centre etc or any on the constituent colleges/Regional centres under the control of the Panjab University and would respect the residents of neighborhood adjacent to the University campuses also.
4. That while raising slogans during demonstration etc, I would not create noise pollution and would follow the decibel standards prescribed by the administration, municipal corporation, police or any other prescribed authority so as to avoid any complaint by the other residents or employees etc present on the campus.
5. That I would not block any street, drive way or path way on and around the University Campus creating any hindrance in egress and ingress of students, employees, visitors etc in the University Campus as also various departments, offices, institutions etc located on any of the campuses under the control of Panjab University.
6. That I would not allow any outsider or stranger in the protests, dharnas or rallies in order to avoid any illegal activities or ugly scenes on the campuses under the control of Panjab University. If any, outsider or stranger is found in any protest, dharna or rally in which I am a participant, the University authorities would be free to hand over these outsiders and strangers to the police or any other authority as the case may be.
7. That I would not deface or cause damage to any of the properties of the Panjab University by pasting/erecting any stickers/banners/posters etc in any manner and if any such stickers/banners/posters etc of any party, students union, organization of which I am member, is found to be there, the Panjab University would be free to get the same removed at the cost and expense of the union/organization concerne

8. That I will always wear my original identity card and on completion of my studies from the University I undertake to deposit my identity card with my department.

9. I will always use the vehicle which I have been authorized regarding which the University has issued parking sticker. The parking sticker will be affixed on that authorized vehicle.

10. I will not carry any fire arm, baseball bat, sword, knife, rod and any other such material which can be harmful for others.

11. That in case I am found to be violating any of the above conditions, or willfully participating in any act/demonstration/dharna/rally etc. by any student union or organization which is in violation of any of the above conditions, the Panjab University would be free and competent to debar me from appearing in any examination and on repeating the violation, my admission shall be liable to be cancelled. On further repeating the violation, my entry in any of the campuses under the control of the Panjab University would be banned and/or I shall be derecognized by the University and ineligible to contest or participate in any election etc of the University.
